

# HIDDEN LAKE KAYAK/PADDLE BOAT RENTALS

## KAYAKS/PADDLE BOAT LIABILITY RELEASE

**Please read carefully. This is a release of  
liability and waiver of legal rights.**

1. I agree to return it in the same condition as I received it, normal wear and tear accepted. I understand and agree that I am responsible for the paddleboat, kayak and any protective equipment provided. I acknowledge that Hidden Lake Kayak Rentals has advised me the use of a protective life jacket is mandatory.
2. I agree to transport the rental equipment in a safe manner. It is my responsibility for all damages or replacement of the kayak/paddle boat due to neglect or accident while transporting. If Hidden Lake Kayak Rentals does not feel that transportation is safe and effective, then the rental will be canceled.
3. If I am signing this liability release on behalf of a minor, less than 18 years of age (“the child”), I represent that I am the parent and/or legal guardian of the child; I accept responsibility for all the child’s medical expenses incurred in connection with the Activity; I agree to indemnify the Released Parties for any and all claims brought by the child; and I agree to indemnify the Released Parties for any and all claims brought by a third party arising in connection with the child.
4. In consideration of the renting a kayak/paddle boat from Hidden Lake Kayak Rentals, I agree to release and hold harmless Hidden Lake Kayak Rentals, its subsidiaries and affiliates, their respective agents, directors, officers, owners, contractors and employees (collectively “the Released Parties”) from any and all claims I might have as a result of the Activity, including those claims based on negligence. Additionally, I agree to indemnify the Released Parties for any and all claims whatsoever brought by a third party for any damage which I may cause or which any other person may cause while engaged in the Activity.
5. In exchange for Hidden Lake Kayak Rentals allowing me to rent the aforementioned equipment, I contractually agree that any and all disputes between myself and Hidden Lake Kayak Rentals arising from my use of this equipment OR my participation in the Activity, INCLUDING any claims for personal injury and/or death will be GOVERNED BY THE LAWS OF THE STATE OF and EXCLUSIVE JURISDICTION thereof will be in the state court residing in the county(Butler) where the alleged tort occurred or federal court of the State of Ky.

6. I agree that if any portion of this release is found invalid or unenforceable, the remaining provisions will be fully enforceable to the fullest extent allowed by law.
7. This rental is for one day. The same day you pick up kayaks/paddle boats you bring them back. If you do not you will owe a second day rental fee!

**This agreement is binding on my estate, heirs, administrators and assigns.**
